For good and valuable consideration, the receipt of which is hereby acknowledged, the undersigned hereby agrees as follows.

**I agree to play paintball and/or laser tag at my own risk. I am aware that Safari Ridge Adventure Paintball and/or Laser Tag are physically strenuous games. I understand that the playing fields are in an unsupervised outdoor wilderness area that is largely in it's natural state and that during the course of the game, players are required to scramble over loose rocks, fallen trees, branches, etc. as well as man-made obstacles and structures and that the risk of injury to myself and others from these factors, from the equipment, and from other players is heightened accordingly.**

Photo & Video Release: I hereby irrevocably grant Safari Ridge Adventure Park Ltd. (Kelowna), its successors and partners the right to record my likeness and/or voice on tape, film or digital media, to edit such tape or film or digital media at their discretion; to incorporate the same into video, tv, radio, web or print advertisement or video for Safari Ridge Adventure Park promotions.

I agree to obey the Safety Instructions and Rules and to further use the rental equipment so as not to injure myself or other players. I agree that my right to play the game and use the rental equipment may be terminated without refund if I fail to follow such Safety Instructions and Rules.

I accept full responsibility for return of all equipment in good condition or to pay replacement cost upon termination of the game.

I, on behalf of myself, my estate, heirs, executors, administrators and assigns do hereby indemnify the owners of Safari Ridge Adventure Park, their suppliers, the property owners and their respective agents, officers and employees ("Releasees") from any and all claims, actions, lawsuits, procedures, costs, expenses, damages and/or liabilities whatsoever connected with, or resulting from playing or spectating paintball and/or laser tag and/or from the use of equipment or premises whether resulting from the negligence of any party or otherwise. I further agree to indemnify the same said parties

against any and all liabilities that may arise between myself and a third party.

I have read and fully understand this Player Release and Agreement and recognize that it is legally binding contract. If I have any doubts concerning any aspect of its' content, I will not play until I obtain legal advice. **I certify that I am at least 19 years of age and in good health and intend to be bound by this agreement.**
